TERMS AND CONDITIONS:

1. The bidders must submit their Registration No., Sale tax No. and PAN No. along with their quotations.
2. Quotation form may be obtained by any interested supplier on any working day from 10:00 AM to 4:00 PM w.e.f. 02.08.10 to 17.08.10 on submission of formal written request to this effect to Manager (PCD), Dhaura-Sidh Hydro Electric Project SJVN, H.No.-113, Ward No.-1, Krishna Nagar, Hamirpur (HP) and can also be downloaded from the SJVN website www.sjvn.nic.in and www.tenders.gov.in
3. The quotations should be submitted in a sealed cover super scribed “**“Purchase of Gym items for recreation for DSHEP, Hamirpur”**” and must be submitted duly addressed to undersigned on or before 18.08.10 by **1:00 PM** and shall be opened on the same day at **3:00 PM** in the presence of bidders or their authorized representatives who wish to be present.
4. The quotation must be accompanied with an Earnest Money Deposit (EMD) amounting to **Rs.3,700/-** only in the form of a Bank Draft/Banker’s cheque in favour of SJVN, DSHEP, Hamirpur, payable at Punjab National Bank Hamirpur (H.P.). The quotations without Earnest Money shall be out rightly rejected.
5. The quotation shall be submitted in two separate sealed envelopes in the following manner:
Part-I: EMD and Techno-Commercial bid comprising of copy of valid CST/GST/VAT Registration No., PAN, brochure showing complete specifications of the quoted items & an undertaking to the effect that there is no deviation from the standard terms and conditions of the NIQ.
Part-II: Price Bid.
6. Quotations shall be received up-to 1:00 PM on the date of opening specified above and Part-I & Part-II shall be opened on the same day at 3:00 PM in the office of undersigned. Initially, **Part-I** i.e. EMD & techno- commercial bid shall be opened and after confirming the receipt of EMD, **Part-II** i.e. Price bids shall be opened on the same day only of those bidders who will qualify the conditions/ criteria of techno commercial bid in the presence of vendors or their authorized representatives who wish to be present.
7. Prices: - Firm prices for delivery **FOR Hamirpur** by road transport **inclusive of assembling/fixing of gym items in the premises of DSHEP at Hamirpur** be quoted & valid for 120 days from the date of opening. Rates are to be quoted in BOQ only.
8. The prices should be inclusive of Excise Duty, Railway Freight, Road Transport, Risk Insurance, Packing & forwarding etc. but exclusive of Sales Tax/VAT.

9. Sales Tax/Vat : Indicate clearly the rate of applicable Sales Tax, VAT.
10. Discount offered, if any shall be indicated at the place where prices have been quoted. The discount offered anywhere else shall not be considered.
11. Delivery: The complete material shall be supplied and assembled within 30 days from the date of issue of supply order.
12. The items shall be under Warranty/Guarantee for a period of one year.
13. The supplier shall ensure assembling and fixing of gym items in the premises of DSHEP at Hamirpur.
14. **Security deposit:** The earnest money i.e. Rs.3,700/- shall be retained as security deposit. In case of default and non-fulfillment of the terms and conditions of the purchase order, your security deposit shall be forfeited without prejudice to other rights arising or accruing to the corporation relating to damage for delay in delivery made in the purchase order. It will however be refunded after the expiry of warranty period.
15. **Payment:** 100% payment of ordered value shall be released within 30 days after complete supply and successful assembling/fixing of gym items to the entire satisfaction of SJVN.
16. The purchaser reserves the right to increase/decrease the quantity at the time of placing the order.
17. Telegraphic/Tele Fax/Conditional/E-mail quotations will not be entertained.
18. In case 18.08.10 happens to be holiday the quotations shall be accepted/opened on the next working day at the same time and place.
19. L.D Charges: If the material is not supplied within the stipulated period, L.D. charges @ ½% per week or part thereof shall be levied for the late supply of materials subject to maximum up to 5% of the value of items/ materials not received.
20. The purchaser reserves the right to reject any or all the quotations without assigning any reason thereof.
